Foster to Adopt Agreement

I agree to foster the above dog with the intention of adopting it once it has been spayed or neutered upon veterinary recommendation. Either now or after spay/neuter, I will complete and sign an adoption contract with the Rescue and pay the adoption fee. If the signing of such a contract and payment occurs before spay/neuter it is for convenience only, and ownership of the dog will transfer to me only on the date of spay/neuter. Until then I understand and agree I am not the owner of the dog.

I agree I will not surrender this dog during the time of fostering to anyone but the above Rescue. I agree to promptly return all calls and emails made to me by the Rescue within 12 hours or less. I understand that dogs can suddenly and unexpectedly become ill or be born with abnormalities that do not exhibit immediately. I agree to call or otherwise communicate with my contact person at the Rescue at once, if the dog exhibits any signs of illness, becomes injured, if I have questions, experience any problems with the dog of any kind, or should I need to temporarily board this dog with someone else. I understand the Rescue has arrangements with several vets in the St. Louis area and I agree to use the services of said vets and coordinate with my contact person for obtaining medical attention for this dog, even in the case of emergency.

I agree that the Rescue will supply worming and vaccinations for this dog and administer them for me unless other arrangements are made, all at the expense of the Rescue, until the day of spay/neuter. I agree the Rescue will supply other medicines as prescribed by a Rescue veterinarian at its expense, and will pay for all medical treatment required for this dog on the condition that said treatment is provided by one of its veterinarians. I agree the Rescue will pay for this dog's spay or neuter once approved by a veterinarian, if the spay/neuter is performed by one of the Rescue's veterinarians. If I use a different veterinarian I agree the cost of the procedure will be at my own expense unless other arrangements are made with the Rescue, and the adoption fee for the dog may not be adjusted. I agree not to spay or neuter this animal without the knowledge or consent of the Rescue.

I agree the Rescue is not responsible for any damage to my home, my personal effects, other animals or people caused by this dog, and will hold the Rescue harmless for any such damage. If I do not abide by the terms of this agreement I understand and agree that the Rescue will ask for the return of the dog and provide the reasons for said demand, and I will allow the Rescue access to my home and surroundings for this purpose. My refusal to relinquish this dog to said Rescue may result in legal action by the Rescue, in which event the Rescue is entitled to all damages arising from my failure to relinquish the dog to them, including but not limited to court costs and attorney fees.
